The health and safety of children, staff, and families is the top priority of Jack & Jill Children’s Center. In light of recent events, we have made the difficult decision to close the child care center at the end of the day (6:00 p.m.) on Thursday, March 19, 2020. Our plan is to resume operations on April 16th in line with the Center for Disease Control (CDC) and State officials. **Parents will not be required to pay tuition or fees during this time.**

Even though our building will be closed, our support of your child’s growth and learning will not stop! We ask that you ensure your contact information is “up to date” in our Procure system. Our teachers have begun organizing educational activities to keep children engaged during the coming days. We will use your contact information to share these activities and other learning opportunities for your family. We will be placing an emphasis on physical movement to promote health and wellbeing.

We ask that you continue to practice proper handwashing and continue healthy hygiene routines.
